<p><u>Terms &amp; Conditions:</u></p> <p>In consideration for being accepted and allowed to participate in this Project, I freely and voluntarily agree as follows:</p> <ol style="list-style-type: none"> <li>1. To unconditionally and fully release, hold harmless, indemnify, defend, and discharge (hereinafter collectively referred to as the “Release”) CAL from liability for any direct or indirect loss, expense, liability, claim, suit, proceeding, demand, judgment, assessment, action, costs, fees, or damages of whatever kind or nature, either in law or in equity, arising from or related to my involvement in or presence at the Project, including loss, illness, injury or damage to myself or property (hereinafter collectively referred to as the “Claims”) regardless of whether such Claims are accrued or are hereafter acquired.</li> <li>2. I understand and agree that CAL does not assume any responsibility for or obligation to provide medical, health, or disability insurance, and I waive any claim to such coverage against CAL. I give permission to CAL to obtain medical assistance in the event of an emergency. This permission will include transportation, the administration of medicines, surgical treatment, X-ray examination or hospitalization as might be ordered by a licensed medical doctor. I release and discharge CAL from any and all liability for any first aid rendered, treatment performed, or transportation provided or arranged pursuant to this consent.</li> <li>3. I understand and agree that I personally assume responsibility for my actions. I agree that I am responsible for following all rules communicated to me before and during the Project. I agree that my participation is a privilege, not a right, and CAL reserves the right to dismiss me from the Project at my expense with no refund, and/or to refuse to allow my participation in future activities. I acknowledge that I have a</li> </ol>	

responsibility to act within the limits of my ability, to heed all warnings and instructions regarding participation in the Project, to maintain control of my person, equipment or devices, and to refrain from acting in any manner that may cause or contribute to death or injury to myself or others or damage to property. I agree that I will not engage in any illicit, unlawful or illegal activities. To the maximum extent possible, I understand, assume, and accept the risks and hazards, either known to me or not readily foreseeable, involved in participation in the Project.

4. I understand and agree that CAL has a hostage policy that states that CAL should not yield to demands, including the payment of ransom or other extortion, issued through the use of hostage taking or extortion.
5. This agreement is governed by the laws of the Republic of Singapore, and is intended to include all claims made by my family, estate, heirs, personal representatives or assigns. Any dispute shall first be referred for mediation by CAL and myself (collectively known as “the Parties”). Such mediation shall be private and confidential and the parties shall be bound by the terms of the mediated settlement. If the dispute cannot be settled within six (6) months, then either party may refer the dispute for final resolution by arbitration in English at the Singapore International Arbitration Centre (“SIAC”) before one (1) arbitrator in accordance with the prevailing Arbitration Rules (the “SIAC Rules” of the Singapore International Arbitration Centre for the time being in force, which rules are deemed to be incorporated by reference in this Clause.
6. By signing this Agreement, I consent to CAL and its divisions to collect, use, retain, disclose and transfer my personal data to CAL’s authorised service providers and ministry partners in and out of Singapore for distribution, administration and communication purposes according to CAL’s privacy policy which is available on <http://www.cru.org.sg/privacy-policy/>. You may choose to withdraw your consent by emailing the data protection officer at “corpcomms@cru.org.sg” in which case, this Agreement may be terminated by CAL if CAL is not able to meet its obligations under this Agreement following the withdrawal of the consent.
7. I will regard as strictly confidential all information about the beneficiaries served during the Project and further agree not to disclose in any form or manner all administrative, operational and other aspects of the Project, as well as the involvement of CAL with respect thereof, save with the prior knowledge and consent of CAL.

## CRU SINGAPORE STATEMENT OF FAITH

Please sign the Statement of Faith below if you completely adhere to it.

The sole basis of our beliefs is the Bible, God's infallible written Word, the sixty-six books of the Old and New Testaments. We believe that it was uniquely, verbally and fully inspired by the Holy Spirit, and that it was written without error (inerrant) in the original manuscripts. It is the supreme and final authority in all matters on which it speaks.

We accept those areas of doctrinal teaching on which, historically, there has been general agreement among all true Christians. Because of the specialized calling of our movement, we desire to allow for freedom of conviction on other doctrinal matters, provided that any interpretation is based upon the Bible alone, and that no such interpretation shall become an issue which hinders the ministry to which God has called us.

We explicitly affirm our belief in basic Bible teachings, as follows: -

1. There is one true God, eternally existing in three persons – Father, Son and Holy Spirit – each of whom possesses equally all the attributes of Deity and the characteristics of personality.
2. Jesus Christ is God, the living Word, who became flesh through His miraculous conception by the Holy Spirit and His virgin birth. Hence, He is perfect Deity and true humanity united in one person forever.
3. He lived in a sinless life and voluntarily atoned for the sins of men by dying on the cross as their substitute, thus satisfying divine justice and accomplishing salvation for all who trust in Him alone.
4. He rose from the dead in the same body, though glorified, in which He lived and died.
5. He ascended bodily into heaven and sat down at the right hand of God the Father, where He, the only mediator between God and man, continually makes intercession for His own.
6. Man was originally created in the image of God. He sinned by disobeying God; thus, he was alienated from his Creator. That historic fall brought all mankind under divine condemnation.
7. Man's nature is corrupted, and he is thus totally unable to please God. Every man is in need of regeneration and renewal by the Holy Spirit.
8. The salvation of man is wholly a work of God's free grace and is not the work, in whole or in part, of human works or goodness or religious ceremony. God imputes His righteousness to those who put their faith in Christ alone for their salvation, and thereby justifies them in His sight.
9. It is the privilege of all who are born again of the Spirit to be assured of their salvation from the very moment in which they trust Christ as their Savior. This assurance is not based upon any kind of human merit, but is produced by witness of the Holy Spirit, who confirms in the believer the testimony of God in His written Word.
10. The Holy Spirit has come into the world to reveal and glorify Christ and to apply the saving work of Christ to men. He convicts and draws sinners to Christ, imparts new life to them, continually indwells them from the moment of spiritual birth and seals them until the day of redemption. His fullness, power and control are appropriated in the believer's life by faith.
11. Every believer is called to live so in the power of the indwelling Spirit that he will not fulfill the lust of the flesh but will bear fruit to the glory of God.
12. Jesus Christ is the Head of the Church, His Body, which is composed of all men, living and dead, who have been joined to Him through saving faith.
13. God admonished His people to assemble together regularly for worship, for participation in ordinances, for edification through the Scriptures and for mutual encouragement.
14. At physical death the believer enters immediately into eternal, conscious fellowship with the Lord and awaits the resurrection of his body to everlasting glory and blessing.
15. At physical death the unbeliever enters immediately into eternal, conscious separation from the Lord and awaits the resurrection of his body to everlasting judgment and condemnation.
16. Jesus Christ will come again to the earth – personally, visibly and bodily – to consummate history and the eternal plan of God.
17. The Lord Jesus Christ commanded all believers to proclaim the gospel throughout the world and to disciple men of every nation. The fulfillment of that Great Commission requires that all worldly and personal ambitions be subordinated to a total commitment to "Him who loved us and gave Himself for us."

Without mental reservation, I hereby subscribe to the above statements and pledge myself to help fulfill the Great Commission in our generation, depending upon the Holy Spirit to guide and empower me.
